Employers Need Training

1. To understand and comply with federal law
2. To know the responsibilities of the employer
3. To protect employees from exposure to serious diseases
4. To protect the children and community

Federal Law

- 29 CFR 1910.1030 –a copy of the law must be available to every employee
- The Law is available on the internet (see the handout Sample Exposure Control Plan for URL)

The Federal Law:

**29 CFR Bloodborne Pathogens
1910.1030(g)(2)(i)**

1. Employers shall ensure that all employees with occupational exposure participate in a training program provided at no cost and during working hours.
2. Employees must have opportunity for interactive questions and answers with a trainer.
3. The Exposure Control Plan must be site specific.

Why Does This Matter to YOU

- Responsible for the care of children
- Children get hurt or have blood or body fluid related events
- Employees come into contact with blood or body fluids
- Employees may become infected with a dangerous disease
- Employers have duty to protect employees

EXPOSURE CONTROL PLAN¹

Instructions: The sample Exposure Control Plan is intended to serve as a guide for child care employers to the federal **Occupational Safety and Health Administration (OSHA) Bloodborne Pathogens (BBP)** standard (29 CFR 1919.1030). A central component of the requirements of the standard is the development of an exposure control plan (ECP). The intent of this sample is to provide child care employers with an easy-to-use format for developing a written exposure control plan. Each employer will need to adjust or adapt the sample for their business's specific use. The information contained in this sample is not considered a substitute for the OSH Act or any provisions of OSHA standards. It provides general guidance on a particular standard-related topic but not for specific compliance requirements.
